The pay rate has been increased in order to attract potential security guards, but this pay increase does not impact the security budget. The library is hoping to hire a new security guard for Saturdays as soon as possible.

- STEAM programming continues to grow at the library. A staff development day was spent in the Makerspace so that there could be better patron support on days when our Makerspace Coordinator is unavailable.

- The library was nominated for the Community Support and Spirit award from the Chamber of Commerce.
- The library successfully received funding for 2 summer students.
- The library is waiting to hear about a request from the Huronia community Foundation Smart Caring grant for a hydroponics system in the library.
- Staff worked very hard with a group of volunteers to complete over 300 free tax returns this year.
